

AMMUNITION ACCOUNTABILITY ACT

In 2008, 18 states independently introduced their versions of ammunition control called the Ammunition Accountability Act. It should be reiterated here that the legislations were entirely efforts by the states and was not initiated by the federal government.

The Ammunition Accountability Act and the corresponding website are run by a company that developed the technology necessary to enforce the same legislation they lobby for. In other words, the founders of the Ammunition Accountability Act are pushing legislation which will have a direct and substantial financial benefit to them.

The legislation calls for each individual piece of ammunition produced to be etched or stamped with a unique serial number. This patented technology was developed by Russ Ford and his business partners Steve Mace and John Knickerbocker of Seattle, Washington.

Ford and his associates were unable to convince any ammunition manufacturers to use their technology, so they hired a lobbyist to push for state-level ammunition tagging legislation.

In summary, the Ammunition Accountability Act was introduced by 18 state legislatures in 2008 and failed to pass during the course of the year. 2009 has seen fewer comparative bills with a few that were carried over from the previous sessions. More attempts at ammunition control will without doubt continue to resurface again in the future.

For the states that are not yet affected, you could go to your legislature's website and type in keyword "coded ammunition" or "ammunition" under Bill Search to keep watch. Each patriot must remain vigilant of their state's laws since the control of ammunition is an indirect path to controlling our rights to bear arms.
